## Pohutukawa II Distribution 23 November 2015

We are delighted to advise that the Board has approved a gross distribution of 35.05 cents per share (cps).

The distribution includes the capital proceeds received for Pohutukawa II's (PII) shareholding in Transaction Services Group, following the realisation of Direct Capital's entire shareholding in that company. The capital proceeds provide a capital return equivalent to 33.67 cents per PII share.

The distribution of 35.05 cps also includes fully imputed dividends totalling 1.38 cps received from four of our portfolio companies.

The distributions will be paid to your nominated bank account on Monday 23 November 2015.

The table below shows a breakdown of the distribution, including the net cents per PII share before your prescribed RWT/NRWT deductions are deducted from the dividend component only. The capital portion of the distribution is non-taxable (if shares are held on capital account):

## Returns to Date

Following this distribution shareholders will have received total gross returns of 69.61 cps compared to capital of 62 cps contributed. Post this distribution the net asset value of the portfolio is approximately 30 cps after allowing for the manager's earn-out.

This is an outstanding result for Pohutukawa II and we congratulate our investment manager Direct Capital on this milestone achievement.

You have contributed 62 cps of the 80 cps capital commitment. 18 cps remains uncalled.
